

# Uninterruptible Power Supply (UPS) Limited Warranty

This Detroit Diesel Spectrum product has been manufactured and inspected with care by experienced craftsmen. If you are the original purchaser, the Detroit Diesel Spectrum manufacturer warrants, for the period indicated below, each product to be free from defects in materials and workmanship. Repair, replacement, or appropriate adjustment at the Detroit Diesel Spectrum manufacturer's option will be furnished if the product, upon the Detroit Diesel Spectrum manufacturer's inspection, is found to be properly installed, maintained, and operated in accordance with the Detroit Diesel Spectrum manufacturer's instruction manuals. A Detroit Diesel Spectrum distributor, dealer, or authorized representative must perform startup. This warranty does not apply to malfunctions caused by damage, unreasonable use, misuse, repair or service by unauthorized persons, or normal wear and tear.

## **Equipment Warranty Coverage\***

Two years (24 months) from the date of startup of the system or 30 months after the date of shipment by the manufacturer, whichever occurs first.

## **Battery Performance Warranty Coverage\*\***

Five years (60 months) from the date of startup of the system or 66 months after the date of shipment by the manufacturer, whichever occurs first, provided that during any storage periods, battery charge is maintained in accordance with the operation and maintenance manual requirements, or a total discharge from each power module of not less than 625 megajoules occurs.

\* Some restrictions may apply. Contact your Detroit Diesel Spectrum distributor for full details.

† The battery performance warranty requires that the battery charge be maintained during storage according to the instructions. The battery performance warranty requires that the system not be operated in ambient temperatures exceeding 36°C (97°F) without air conditioning. The system data log shall be accepted as the record for the energy used during each battery power run and shall be the basis for determining the battery warranty status for energy consumption.

The following will **not** be covered by the warranty:

1. Normal wear, periodic service, and routine adjustments.
2. Damage caused by accidents, improper installation or handling, faulty repairs not performed by an authorized service representative, or improper storage.
3. Damage or performance issues due to startup by an unauthorized technician.
4. Damage caused by operation above or below rated capacity, voltage, or frequency; modifications; or installation contrary to published specifications, codes, recommendations, and accepted industry practices.
5. Original installation charges and startup costs.
6. Rental of equipment during performance of warranty repairs.
7. Damage caused by negligent maintenance such as:
  - a. Failure to provide a clean, dry environment.
  - b. Failure to perform scheduled maintenance as prescribed in supplied manuals.
  - c. Use of other than factory-supplied or -approved repair parts and/or procedures.
8. Non-Detroit Diesel Spectrum-authorized repair shop labor without prior approval from the Detroit Diesel Spectrum Warranty Department.
9. Expenses incurred investigating performance complaints unless the problem is caused by defective Detroit Diesel Spectrum materials or workmanship.
10. Maintenance items such as fuses, lamps, and adjustments.
11. Failure due to a lack of battery maintenance during storage.

A Startup Notification form must be on file at the Detroit Diesel Spectrum manufacturer. A Startup Notification form must be completed by the Seller and received at the Detroit Diesel Spectrum manufacturer within 60 days after the date of initial startup. Systems will automatically be registered by the Detroit Diesel Spectrum manufacturer using the the Detroit Diesel Spectrum manufacturer ship date as the warranty start date.
